RN-BSN COMPLETION

Admission

The RN-BSN Completion program is available for registered nurses with an associate degree or diploma in nursing who meet University admission requirements. Clayton State participates in the Georgia Statewide Articulation Model.

Nursing application is separate from University application and admission. The distance learning program can be completed on a full-time or part-time basis. Graduates are prepared to practice in diverse health care settings, including hospitals, homes, clinics, hospice, industry, and the community.

Minimum admission requirements include (details on the School of Nursing website):

- Unrestricted current nursing licensure in the United States or eligibility for licensure
- b. College grade point average (GPA) of 2.00 on 4.00 scale.
- c. Completion of 45 semester hours of BSN core curriculum with grades of C (or K or S) or better in all natural and behavioral science, math and Area F courses at the time of application and 60 semester hours at the time of enrollment in the nursing program.
- d. Successful completion of the legislative requirements.
- e. Eligible for clearance on criminal background check and drug screening.

- i. Apply selected theoretical frameworks and evidence-based practice to nursing practice in diverse settings

* CHEM 1151 Survey of Chemistry I and CHEM 1152 Survey of Chemistry II or CHEM 1211 Principles of Chemistry I and CHEM 1212 Principles of Chemistry II are the preferred Core IMPACTS (T) science sequence courses (with laboratory). CHEM 1151 Survey of Chemistry I or CHEM 1211 Principles of Chemistry I are required regardless of completion of other Core IMPACTS (T) science sequence options. MATH 1401 Elementary Statistics is also required in Core IMPACTS (T). PSYC 2103 Intro to Human Development is preferred in Core IMPACTS (S).

These courses can also be applied to the Field of Study and Elective areas as needed to fulfill degree completion requirements. All require a grade of C or higher.

- Lab science sequence required for this Health Professions major.
 Upon successful completion of NURS 3197 Professional Nursing Practice, RNs will receive up to 30 semester hours of credit.
- The Course Block Credit will appear as NURS 2000 within a student's transfer credit.

Academic Standards

Nursing students must maintain a semester grade point average (GPA) of 2.00 ("C") to progress in the program. A minimum grade of "C" is required in all upper division and major courses. Students who receive a "D", "F", "WF", or "U" in any nursing course may repeat that course one time only on a space available basis. Students who receive any two of the following: "D", "F", "WF", or "U" in any two nursing courses may not continue in the program. All students are required to finish all coursework
